## FREEMASONRY IN ISRAEL

As we approach the spring season and the holidays of Passover and Easter, we are reminded of just how closely Christianity and Judaism are related. The practice of Freemasonry in Israel could and should be a model for the rest of the world. The two official languages in Israel are Hebrew and Arabic. Masonic lodges operate in those two languages, as well as in six others, namely: English, French, Spanish, German, Rumanian, and Turkish. There are eight (8) lodges located in the City of Jerusalem, and many others can be found throughout the entire country.

Israel is often criticized by the media as being biased, dogmatic, and abusive towards others who don't fit the mainstream philosophies. Masonry offers Arabs and Israelis the opportunity to sit down next to each other and practice *Brotherhood*. It appears in Israel that the bonds of our brotherhood are stronger than the bonds of traditional Arab vs. Israeli hate.

Another example of Israeli tolerance of self-expression, especially in Freemasonry, is present on the altar in every lodge in Israel. In a lodge in the United States, you will usually find just one bible on the altar. This bible either corresponds to the majority faith of the lodge members, or to the faith of the candidate upon whom the degrees are being conferred. In Israel, *all* lodges utilize all three (3) volumes of sacred law which are opened side-by-side on the altar. These volumes are the Hebrew Bible (The Tanach), the Christian Bible, and the Koran (Islam).

Further evidence of social tolerance is denoted by the following symbol: a Jewish Star of David, a Christian Cross, and a Muslim Crescent are all intertwined with a square and compasses. Oftentimes it is possible to attend a lodge meeting where more than one language is used during the meeting.

I should like to conclude this brief expose' by quoting the Grand Lodge of Israel. "Despite its small size, the Grand Lodge of Israel can be proud of having been able to foster and develop a true and fraternal spirit within its lodges even under the most trying external circumstances. We must endeavor to bring our message of enlightenment, toleration, and fraternal love to all. Thus helping to build a better world for our children."

## The TRUE SPIRIT of AMERICA

Remember the guy who got on the plane with a bomb built into his shoe and tried to light it? U.S. District Court Judge William Young sentenced 'would-be bomber' Richard Reid to *life imprisonment* plus 110 years.
