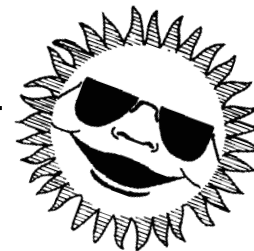

GREAT INSIGHT from a young officer

Editor's note: this article from a young member with only about 3-years of Masonry behind him, seems to your editor to be extremely insightful. In his short stint in the Masonic order, Bro. Stafford is advancing at a sprinter's pace to learn lectures, charges, protocol, and more. Keep your eye on him – he's a real "comer".

As our Lodge recently celebrated one of the most profound principles of Freemasonry, "Brotherhood", I would like to take this time to reflect on what this *principle* means to me.

According to the Grand Lodge of Ohio's Officer's Handbook: *In the usages of Freemasonry, "Brother" is neither a sentimental nor a familiar form of address, but it is a title, a distinction, and an honor, as much as "Right Wor. Bro." and Most Wor. Bro.", and must always be used as such.*

While this is true, and should be respected by those of us of the craft, so might the word "Brother" also remind us of its more personal and familiar designation.

When I think of the word "Brother", I think of siblings. I do not actually have a brother, but I do have a sister. When I joined the Masons and my lodge, I received, upon my initiation, the title of "Brother". As time went on I also received instruction on how to treat my Brothers. The funny thing about this title and the rules associated with it, I could not help but notice the stark similarities between the two definitions.

As Masons, we are to go out of our way to assist a "Brother" in need of help. This same rule applies to my sister or to my family in general. We are not supposed to cheat a "Brother" or take advantage of him for personal gain. Again, something I would apply to my family.

Much like in a family, there is no rule stating that everyone has to get along and agree with each other. In Masonry, while we have some say about who joins, we don't always get to pick our "Brothers", and we definitely don't always agree or get along. Like family, however, we are all related. In this case we are related by the virtues of Freemasonry and that profound principle of Brotherhood which encourages us to put aside our differences; break bread together; make decisions that benefit the group as a whole; and support one another in all of our undertakings.

So while The Grand Lodge Handbook says, "*Brother*' is neither a sentimental nor a familiar form of address", the bond we form with the Brethren of this fraternity is difficult to be considered anything less than a family. **You can't have a brother without a family.**

So next time a "Brother" shows up in lodge wearing bright green, purple, or white socks, or a "Brother" totally 'botches' his lines while giving a Charge or a Lecture, show him some Brotherly Love. From personal experience I know that the "Brother" will appreciate the support and encouragement.

THE CROWN JEWEL – Brotherhood Night

If you are a long-time member of Forest City Lodge, you may remember the December meeting in 1973, when our late Bro. Emanuel Gateman was Worshipful Master. His activities chairman that year was the late Illus. W.B. Bert M. Tobin. Bro. Tobin, always on the look-out for something outstanding for the Lodge, invited his good friend, the late Rabbi Rudolph Rosenthal, along with R.W.B. Rev. Morris Altman, the then Grand Chaplain of Masons in Ohio, to come to Forest City Lodge at this special time of the year to talk about “Brotherhood”.

Both men were eloquent, and at the end of the evening Bro. Altman presented Forest City with a special candle to commemorate not just the evening, but more especially the theme. W.B. Tobin recognized a ‘winner’ immediately, and hence our Annual Brotherhood Night and Night With The Clergy was born. This past December 15th was the occasion of the 38th annual observance of this event.

Not content with what was already a success, Bro. Tobin enlisted the services of W.B. Lewis Fine and Bro. Ben “little brother” Kaufman, both of blessed memory, to help improve and expand Brotherhood Night. Some years later, with the event becoming more and more of ‘a thing’ in Ohio Masonry, Bros. Fine and Kaufman began raising money to ‘put teeth’ into the word Brotherhood. Together they raised considerable sums, much of which was their own contributions, and on Brotherhood Night they invited several worthy charities to attend and receive donations for their respective causes.

Now, many years later, Bro. Ben’s sons, W.B. Jay and Bro. David Kaufman have continued the work of their Dad and his good friend, W.B. Fine. This year, a record amount of money was raised, and checks for \$600.00 were presented to the representatives of: the Cleveland Food Bank, the Grand Lodge of Ohio Charitable Foundation (this year accepted by Grand Master Bradford A. Goebel), the Salvation Army, St. Herman’s House of Hospitality, Temple Israel Ner Tamid, and Trinity Cathedral Church. All funds are used to either feed, house, or in some other way assist those in dire straits.

ONE REASON for the record collection this year was our newly created “17 Cents-A-Day Club”. Early in 2010, your editor suggested that brethren throw 17 cents each day into an empty container, and at the end of the month – or two months, mail in the accumulated \$5.00 or \$10.00. Fourteen of our brethren joined the Club, and with donations ranging from \$5.00 to \$100.00, the Club raised in excess of \$700.00 in just a single year.

Immediately following Brotherhood Night, Bro. Alan Apisdorf and W.B. Ronald Wolfe each made a 3-month, 17 cents a day contribution to get the ball rolling for 2011. If each of my brethren would consider just a 2-month contribution, the amount raised for our next Brotherhood Night will again set a new record, and will allow us to include additional deserving organizations.

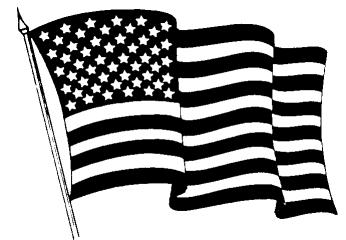

WOLFGANG AMADEUS MOZART – A true Master Mason of Freemasonry – Part II

Here in the 21st century, it is difficult for us to get a sense of the enormous and threatening tensions created by ‘radical’ ideas which included the rights which we take for granted. Back in the latter part of the 18th century, however, such things as (1) individual rights, (2) the quest for ennoblement of the human spirit, and (3) the pursuit of intellectual goals, were threatening ideas in an era of absolute monarchs, ecclesiastical privilege, and secret police who wished the ‘status quo’ to continue.

In Europe, the results of the 1789 French Revolution (viewed by some as a “Masonic Conspiracy”), coupled with America’s successful venture into democracy, made the ruling classes tremble in fear of any group of individuals who met in the privacy of a Lodge, utilized “mysterious” ceremonies, and could number among their membership: intellectuals, professionals, and in some cases even prominent figures from the

government and aristocracy itself.

In Mozart’s Vienna, Freemasonry had flourished under the Hapsburgs mainly due to the influence of Duke of Lorraine who, himself, was a Freemason. He married Crown Princess Maria Theresa who openly loathed the Craft and continued to seek its abolition through the successive reigns of her husband, Francis I., and later on when co-ruling with her eldest son, Joseph II. In “The Magic Flute”, Mozart was to satirize Maria Theresa as the evil “Queen of the Night”. Later on a myth was circulated alleging that Mozart had been poisoned by Freemasons because his opera had divulged ‘Masonic’ secrets. Nothing could have been further from the truth.
